The Civil 20 (C20) became an Official Engagement Group of the G20 in 2013. Since then, the C20 has grown stronger every year, ensuring that world leaders listen not only to voices representing the government and business sectors, but also to the proposals and demands of civil society, with the aim of protecting the environment and promoting social and economic development, human rights and the principle of leaving no one behind. Our work is guided by our principles of inclusivity, transparency, independence, collaboration, human rights, gender equality and women empowerment. This year the C20 Engagement Group is joined by more than 800 members from global Civil Society in **80 countries** all round the globe.

C20 activities throughout the G20 presidency year, include:

- Speaking at G20 official meetings to represent the demands of civil society and the communities we serve
- Influencing G20 outcome documents including the G20 Leaders' Communiqué
- Producing the <u>C20 Policy Pack</u> which details C20 positions in response to the G20 agenda of the year

- Releasing the C20 Communiqué, which is Civil Society's political declaration to G20 Leaders

This year has demonstrated the need to listen to all voices without discrimination or proxy. We are determined to host the biggest virtual gathering of Civil Society Organizations in the history of the G20, to make sure that no voice is being left behind at this historical conjunction.

We are expecting 4,000+ attendees and participants; including the G20 Presidency and senior officials, G20 Ministers, leaders of International Organizations, Inter-governmental Organizations (IGOs), Non-governmental Organizations (NGOs), global experts, activists and influencers.

Response to COVID-19 for Children in Fragile and Conflict Affect Settings: The Promise of Early Childhood Development

Session Description:

Millions of children are trapped in situations of violent conflict, military occupation and displacement. The COVID-19 crisis is exacerbating their already dire situation, further violating their rights. Science shows that adversity has a detrimental effect on the physical and emotional development of young children. It, also, heralds a new era, asserting that Early Childhood Development is a vital opportunity to promote a culture of peace, building a strong foundation for resilience, social justice and social cohesion. Globally we must guarantee the right to child wellbeing, education and care, through the design and implementation of public policies that promote inclusive Early Childhood Care and Education (ECCE) for all children, with special attention to those who are marginalized, to ensure children's long-term development, learning and health. The panel discussion will demonstrate by science and practice the vital importance of Early Childhood Development (ECD) strategies and services, to mitigate the immediate and long-term impact of the COVID-19 global crisis and its indirect consequences on the most vulnerable young children and families, and will assess global efforts towards achieving universal access to ECCE, and look at the actions needed to expand and guarantee access.

This session will advocate for the need to implement inclusive education policies and highlight key elements that would make it a sound policy. It will also explore the positive effects behind legislation that guarantees free and quality pre-primary ECCE. Guidelines for Child Protection Training for educators will be discussed and explored as this is an increasingly important element to include in any standard teacher development programs.

Rima Salah

Chairperson **Early Childhood Peace Consortium** (ECPC)

Rima Salah, PhD, served as a Member of the United Nations High-Level Independent Panel on Peace Operations (2014-15), and as the Deputy Special Representative of the Secretary-General, U.N. Mission in the Central African Republic and Chad (MINURCAT). In addition, Dr. Salah has had a distinguished career with UNICEF. Her service includes: Deputy Executive Director for UNICEF; Regional Director for West and Central Africa; and UNICEF Representative in Burkina Faso and Vietnam. As a highly effective advocate for the rights of children and women living in fragile contexts, Dr. Salah received many awards of distinction from governments and nongovernmental organizations including the French Legion of Honor. Since 2015, she chairs the Early Childhood Peace Consortium (ECPC), a global movement which advocates investing in the Early Years of life as a powerful strategy for reducing violence, poverty, exclusion, and for building peaceful societies. Dr. Salah is at the Yale Child Study Center.

Ana Margarita Tenorio, PhD serves as Global Technical Director of Education at World Vision. She is an Early Childhood Development professional with over 20 years' experience in 38 countries globally. 

Arab Resource Collective (ARC)



Yale School of Medicine


James F. Leckman, MD, PhD, has served on the faculty at Yale University since 1980. He has pursued an academic career in large part focused on Tourette syndrome and Obsessive-compulsive disorder (OCD). His work on OCD led him to explore evolutionarily conserved obsessive-compulsive behaviors associated with parenting and romantic love. This in turn led him to explore the question whether strengthening families and enhancing child development can be a path to peace and violence prevention. His focus on the transformative power of early childhood development (ECD) led to the convening of the 15th Ernst Strüngmann Forum, "Pathways to Peace: The Transformative Power of Children and Families," as well as the formation of the Early Childhood Peace Consortium, currently being led by Rima Salah. At present, he is working on ECD projects with colleagues in Ireland, Lebanon, Saudi Arabia, Mali, Egypt, Palestine, Israel, Tajikistan, Kyrgyzstan, Vietnam, Timor-Leste, Colombia and Brazil.
